



This Agreement is entered into on **January 1, 2025** (the "Effective Date"), by and between **KL Entertainment (KLG) Sincere Soul Records and Jenla Enterprises LLC**, located at 241 Lynbrook Boulevard Unit 6333, Shreveport, LA 71106 (hereinafter referred to as the "Client"), and **Counting Pennies, LLC** (hereinafter referred to as "CP"), collectively referred to as the "Parties."

1. Scope of Services

Counting Pennies, LLC agrees to provide the following CFO services to the Client starting **January 1, 2025**:

2. Payment Terms

If Counting Pennies, LLC requests information from the Client that is not provided in a timely manner, any related projects or services will be placed on hold until the requested information is



received. Upon receipt, the Client will be informed by the Operations Department of the expected completion timeline or the next steps for their project.

4. Use of Artificial Intelligence (AI)

The Client acknowledges and agrees that Counting Pennies, LLC may utilize Artificial Intelligence (AI) to enhance the accuracy and efficiency of services provided. AI may be used to create reports, improve processes, and deliver other benefits to the Client.

5. Client Responsibilities

The Client agrees to:

- Coordinate and confirm meetings promptly when requested.
- Keep all business bank accounts connected to QuickBooks.
- Remit the agreed-upon service fee promptly.
- Notify Counting Pennies, LLC of any material changes to KLG or Sincere Soul Records.
- Inform the Accounting Manager of any new loans, bank accounts, or lines of credit immediately.

6. Termination

This agreement may be terminated by either party by providing a 30-day written notice of intent to cancel. Notices can be sent to the contact details listed in this Agreement or via email.
